Introductory description

Granulen® E22 ROPP is a granulation product, which does not contain PVC and has been designed for use as the sealing of aluminium ROPP closures. Granulen® E22 ROPP is certified according to the applicable legislation currently in force in the area of contact with food. Normally, it may be used for closures of bottles containing most drinks such as water, fruit juices, milk cold-bottled or pasteurised, wine and alcoholic drinks having an alcohol content up to 45% in volume which will be cold or hot filled or pasteurised. It is not suitable for closures to be used with bottles containing fat.

The manufacturer of ROPP closures and the bottling plant are fully responsible for the testing and determination of fitness for use of Granulen® E22 ROPP for specific final applications. Each customer or end user must conduct their own tests in order to check its fitness for specific applications and treatment methods.
